The parties hitherto agree as follows

- 1. At the request of the Second party, the first party shall depute time to time its administrative staff/experts as visiting faculty to the second party against agreed terms and conditions to deliver lecture on any one of the regular or specialized topics relating to the syllabus of the second party.
- 2. The second party shall extend full assistance/guidance, on demand from the first party with the help of its faculty members/staff, in trouble shooting, drawing, estimating, surveying, laboratory testing, etc, if necessary on agreed terms.
- 3. As per the convenience of the first party, the first party shall offer at the request of the second party, practical training to the final year students of the second party under the guidance of faculty/staff from the later without shouldering any financial obligation. Further, the first party shall not be responsible to bear any risk relating to any casualties/damage faced by any one or more student trainee/s or faculty/staff of the second party during the course of training.
- 4. The first party in any case shall not be responsible for providing employment to the students of the second party who have under the internship training in the factory of the first party.
- 5. The first party shall allow the students of the second party for industrial visits under the guidance of faculty/staff from the second party for half/full day to provide them with an exposure to various equipment, instrument, etc. at mutually agreed terms.
- 6. The second party shall allow the first party to showcase its business activities at the seminar/workshop/conference, etc. organized by the second party at it's own premises on agreeable terms.
- 7. IN ANY OF THE ACTIVITIES MENTIONED ABOVE, WHEREVER FINANCIAL ASPECTS ARE INVOLVED, AMOUNT, PAYMENT CONDITIONS, ETC. SHALL BE SPELT OUT CLEARLY BEFORE STARTING THE ACTIVITY/IES. THE PARTY TO THE MOU WHOEVER IS BENEFITED FROM ANY ACTIVITY/IES, IS MANDATORY TO BEAR ENTIRE FINANCIAL BURDEN CONCERNED TO CONDUCT SUCH ACTIVITY/IES

8. Both the parties shall make provisions to share their respective important R&D facilities in order to promote academic and research interaction in the Cor. D.K. Talukday 2 areas of cooperation.
